8.18 – Matters Arising/ Clerks Report (items in italics updates)

**Playing Field/Rospa Report** – Newby Leisure have carried out repairs and changed one of the seats on the swings. We are still waiting for an invoice for this work

**Lincs County Council – Highways** - The CC have been contacted regarding the puddle outside the school, the condition of the lane by the side of the Church and the parking on the corner of Mill Lane/Sea Dyke Way opposite the school. To date I have not heard anything. Cllr McNally was not at the last meeting to report back to us so I have again (third time) contacted LCC regarding this.

**Speed sign** – I have paid the money to Grainthorpe, hopefully it will be our 'turn' soon.

**BKV** – Hopefully by meeting day I will have the childrens posters that can be put up round the village. We will have vouchers as prizes for best posters. We will discuss donating some funds to the school (S137) so they can put some plants in containers in the War Memorial gardens.

Children's posters were 'judged' at meeting and Councillors were very impressed with all of them, it was particularly difficult to select a winner from amongst them but they did pick out a  $1^{st}$ ,  $2^{nd}$  and  $3^{rd}$ . All posters will be put up round village.

#### 9.18 - Financial

Clerk purchased additional drive for back up. Proposed Cllr Rickett, seconded Cllr Cordy.
